Dear Dr. Roy,

It gives me great pleasure to inform you that the project No. 5804-3 as above submitted jointly by **Dr. Gargi Chaudhuri**, of your institute and **Prof. Francesca Gulminelli**, LPC/ENSICAEN, Caen, France, was recommended by the Scientific Council of CEFIPRA in its 59th meeting held in May, 2017 in France and subsequently cleared by the Governments of India and France. While clearing the proposal, the Indian Government has stipulated the following conditions:

- a) **In case of the visit of foreign scientists to any restricted areas prior approval of concerned Government authorities such as Ministry of Home Affairs may be taken prior to such visit.**
- b) **In case of any exchange of biological material is required, the Indian PI should take prior approval of the concerned Government Agency, such as National Bio Diversity Authority, ICMR, DBT as the case may be.**

Please find enclosed copy of the budget sheet, as approved, which will be taken into consideration for release of funds and visits under the project. The guidelines for the implementation of CEFIPRA project are also enclosed for your reference.

The funds for the 1st year’s budget will be released shortly through bank transfer.

The official date of commencement of the project will be within one month from the date of release of funds for both Indian and French sides. The PIs of the project may propose a mutually agreed starting date to CEFIPRA immediately after receipt of the funds.

Earlier approval letter No. IFC/5804-3/2017/1241 dated November 24, 2017 issued by CEFIPRA in the name of Dr. Dinesh K. Srivastava stands cancelled.
