- This committee shall work broadly as per the provisions of Sexual Harassment of Women at Work Place (Prevention, Prohibition & Redressal) Act, 2013, as amended from time to time
- 2. This Committee will look into the complaints made by female students of HBNI.
- 3. Any complaint of sexual harassment should be forwarded by the student to this committee only after it has already been examined and investigated by the corresponding committee in the CI/OCC and if the student is not satisfied with the outcome.
- 4. The committee shall work broadly as per the provisions of Sexual Harassment of Woman at work place (Prevention, Prohibition & Redressal) Act, 2013 as amended from time to time.

- 5. Depending upon the Constituent Institution/Off-Centre Campus (CI/OCC) at which the student is enrolled the committee will co-opt a nominee of the CI/OCC, to be decided by the Dean (Student's Affairs) of the concerned CI/OCC in consultation with the Director of CI/OC.
- 6. If the complaint is made against the staff member of the CI/OCC, the committee will forward its recommendations to the Competent Authority in the CI/OCC for administrative actions as necessary.
- 7. If the complaint is made against fellow student, the committee will forward its recommendations to the Competent Authority in HBNI for further actions.
