Welcome to the community of the Associate Members of the Abdus Salam International Centre for Theoretical Physics! I am happy to inform you that you have been appointed a

***Regular Associate of the Centre
from 1 January 2012 until 31 December 2017.***

This award is, however, subject to the availability of funds each year. Please refer to the Annex to this letter for details.

During the above period you will be entitled to 210 days living allowance and three round-trip fares. Over the next three years, we expect to be able to substantially increase your living allowance. Each Associateship visit will have a maximum duration of 70 days, with a minimum of 35 days to obtain travel entitlement. 

Dear Dr. Bhattacharjee:

I am writing to inform you that Dr. Rajesh C. Gandhi, of your institute, has been selected as a recipient of an Intensity Frontier Fellowship at Fermilab. The Fellowship is program funded by the United States Department of Energy (DOE) with the goal of creating a dynamic intellectual environment for experimentalists and theoreticians interested in the exploitation of the intensity frontier in particle physics. To this end, the program provides research funding in the form of the Intensity Frontier Fellowships, to intellectual and field leaders in the areas of neutrino physics, muon physics, and other areas.

The selection of Fellows is done by a peer committee of scientists appointed by the Fermilab Director. The majority of the membership of the committee is from outside Fermilab. I am currently serving as chair of the selection committee. You can read more about the program at this link:

Dr. Gandhi has been selected based on his proposal to study possibilities of physics within the LBNE (Long Baseline Neutrino Experiment). This project will send a neutrino beam from Fermilab, near Chicago, to South Dakota, in the west of the United States. It is expected that the project will resolve the question of fundamental symmetry violation of neutrinos, a very difficult and important problem. As part of the project a "near detector" at Fermilab is required. Dr. Gandhi's program will focus on physics opportunities of such a detector in a very intense beam of neutrinos.

As part of the Fellowship goals, Dr. Gandhi will be spending extended time at Fermilab during 2014. The fellowship provides funding to facilitate this. We very much look forward to the opportunity for close collaboration with Dr. Gandhi.

Any travel booked before you establish your visa status will not be reimbursable.

You will only be reimbursed for times when you are in residence at Fermilab. If you plan to travel during your time at the lab, you must provide that information ASAP. You will not be paid/reimbursed for time you are away from the lab. All aspects of the awards must be spent under DOE, Fermilab, and NPC rules and guidelines.

Once you've accepted, please send us a photo and a ~200-word abstract describing your project so we can upload it to the NPC website (<http://npc.fnal.gov>). Lastly, your acceptance means you agree to provide a one-page report at the end of your fellowship, stating what was achieved during your award time.
